

## Maintaining the Church in the 21<sup>st</sup> Century

Well over a decade ago the community of Adderbury set about raising funds and seeking grants for the external refurbishment of St Mary's Church which was in a poor condition. The initial campaign, by the St Mary's Adderbury Rescue Team (SMART), financed major restoration work on the Church in stages from 2005.




Such was the success of the campaign; it was decided to set up a more permanent body to continue to raise funds for maintaining the fabric of the Church into the future.

**The Friends of St Mary's Adderbury (FOSMA)** was duly formed in March 2009 as a registered charity (No:1136252)


In recent years FOSMA has raised more than £150,000 from a series of successful and enjoyable events, generous donations, and friendship fees.

FOSMA contributed to the PCC for the repair of the outside stonework including two new gargoyles around the tower and the cleaning of the rare medieval musicians' frieze.

Other restorations FOSMA funded included the south window (shown earlier); the Lychgate



and a new wrought iron gate in the South Porch



Further window refurbishment is planned, along with improvements to the heating system - with the help of a very generous donation,
